1. Award a Contract for a Partial Roof Replacement

WHEREAS, the White Township Consolidated School District Board of Education ("Board") advertised for bids for the Partial Roof Replacement at White Township Consolidated School ("Project"); and

WHEREAS, the Public School Contracts Law, <u>N.J.S.A.</u> 18A:18A-1 et. seq. ("Public School Contracts Law") provides that the Board must award bids to the lowest responsive and responsible bidder for a project, as is defined in the Public School Contracts Law; and

WHEREAS, the Board previously held a public bid opening for the award of a contract for the Project; and

WHEREAS, the lowest numerical bid was submitted by Arco Construction Inc. ("Arco") with a total bid amount of two hundred eighty-nine thousand dollars (\$289,000.00), which included a thirty five thousand dollar (\$35,000.00) general allowance to be used for unforeseen conditions; and

WHEREAS, the Board has reviewed Arco's bid submission with the Board's professionals and has determined Arco to be the lowest responsive and responsible bidder for the Project; and

NOW, THEREFORE, BE IT RESOLVED, that in accordance with the provisions of the Public School Contracts Law, the Board hereby awards the contract for the Partial Roof Replacement at White Township Consolidated School Project to Arco in the total amount of two hundred eighty-nine thousand dollars (\$289,000.00), which includes a thirty five thousand dollar (\$35,000.00) general allowance to be used for unforeseen conditions; and

BE IT FURTHER RESOLVED, that the Board President, Business Administrator and their designees are authorized to execute a contract on behalf of the Board with Arco for the Partial Roof Replacement at White Township Consolidated School Project, based on Arco's low bid of two hundred eighty-nine thousand dollars (\$289,000.00).
